

# NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.484998 per \$100 valuation has been proposed by the governing body of CITY OF CADDO MILLS.

PROPOSED TAX RATE	\$0.484998 per \$100
NO-NEW-REVENUE TAX RATE	\$0.484068 per \$100
VOTER-APPROVAL TAX RATE	\$0.484998 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for CITY OF CADDO MILLS from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that CITY OF CADDO MILLS may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF CADDO MILLS is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 16, 2025 AT 6:00 PM AT City of Caddo Mills Council Chambers (City Hall), 2313 Main St., Caddo Mills, TX 75135.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, CITY OF CADDO MILLS is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City of Caddo Mills of CITY OF CADDO MILLS at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$
