# **Meeting Minutes**

# NOVEMBER 09, 2021 TUESDAY at 6:00 p.m.

1. INVOCATION

Josh Kinnick gave the invocation.

2. OPEN THE MEETING AND ANNOUNCE THAT A SUPER QUORUM IS PRESENT

Mayor Ron Olson declared a Super quorum present and called the meeting to order at 6:00 p.m. Council members present were Mayor Ron Olson, Mayor Pro Tem Kevin Mosher, Councilman Scott Clements, Councilman John Verity and Council member Ben Bentley and not present was Councilman Chris Davies. City representatives present were City Manager Matt McMahan, City Secretary Jana Sanchez, Police Chief Kimbre Collier, Finance Manager Stacy Smith, Building Official Josh Kinnick, EDC director Joel Richardson, City Engineer Eddie Daniels, And City Attorney Andy Messer.

3. APPROVE MINUTES OF PREVIOUS MEETING: (October 12, 2021)

Mayor Pro Tem Mosher made the motion to approve the previous minutes. Councilman Davies seconded the motion. The motion passed 5-0.

4. OPEN FORUM: Citizens who wish to address the City Council may discuss matters that are not on the agenda and who have not previously expressed to the City Council or City Hall, a desire to discuss such matters. The only response from the Council can be to request these items to be placed on a future agenda for discussion and or action.

Jeff Vondemkamp distributed pictures of the property that was nearby property being proposed for annexation. Vondemkamp's main concern was that the property always is holding water and with the annexation and new developments, he thinks that the problem will increase. Mr. Vondemkamp also thinks it may cause issues with his adjacent property. Dan Kielty advised he has a dog training facility and has been at his property for almost thirty years. Kielty states his facility is extremely noisy due to the dogs and the training equipment, and he doesn't want to have people complaining about his facility. Mayor Olson closed the open forum.

### 6. ACTION/DISCUSSION:

A) Consider and take action on a Resolution 110921 authorizing the mayor to execute a Development Agreement between the City of Caddo Mills, Texas and Jeffrey Cotton, James A. McMahan, James M. McMahan, and MR Joyce, LLC for an approximate 149.587acre tract of land located at 4672 FM 1565 and 4449 CR 2617.

Mr. Ryan Joyce with Michael Joyce Properties discussed the Development Agreement on "Fox Landing", and how the infrastructure plans will be implemented. He reviewed the development guidelines and requirements, regarding the setbacks, stated they will have 80% masonry requirements. He showed the interior and exterior designs of the houses. Joyce said that the development would be geared more to second home buyers, because they are not entry level homes. City Engineer Eddie Daniels wanted to remind everyone he and his team will make sure, everything is property designed correctly such as retention ponds and direction of drainage. Mayor Pro Tem Mosher made the motion to act on Resolution 110921 authorizing the Mayor to execute a Development Agreement between the City of Caddo Mills, Texas and Jeffrey Cotton, James A. McMahan, James M. McMahan, and MR Joyce, LLC for an approximate 149.587acre tract of land located at 4672 FM 1565 and 4449 CR 2617. Councilman Bentley seconded the motion. The motion passed 5-0.

B) Consider and take action on a Resolution 110921-1 authorizing the City Manager to execute a Development Agreement between the City of Caddo Mills, Texas and Stephanie Zimmermann and MR Joyce, LLC for a 154.54 acre tract of land generally located west of CR 2617, south of CR 2613 and east of Hwy 66.

Mr. Ryan Joyce with Michael Joyce Properties discussed the Development Agreement for "Reserve on Brushy Creek". Joyce discuss the similar infrastructure plans as previous development. He said it would have three separate lot types 60 ft, 70 ft and 80ft lots. Joyce went over the handout, and discussed how the water line improvements will take place with a 12 inch water line. Joyce said that there are similar guidelines as the "Fox Landing" Development. Joyce said there will also be a walking running trail as well. Mayor Pro Tem Mosher made the motion to approve Resolution 110921-1 authorizing the City Manager to execute a Development Agreement between the City of Caddo Mills, Texas and Stephanie Zimmermann and MR Joyce, LLC for a 154.54 acre tract of land generally located west of CR 2617, south of CR 2613 and east of Hwy 66. Councilman Bentley seconded the motion. The motion passed 5-0.
