## **Meeting Minutes**

## DECEMBER 14, 2021 TUESDAY at 6:00 p.m.

#### 1. INVOCATION

Josh Kinnick gave the invocation.

2. OPEN THE MEETING AND ANNOUNCE THAT A QUORUM IS PRESENT

Mayor Ron Olson declared a quorum present and called the meeting to order at 6:00 p.m. Council members present were Mayor Ron Olson, Mayor Pro Tem Kevin Mosher, Councilman Chris Davies, and Councilman John Verity. Members not present were Council member Ben Bentley and Councilman Scott Clements. City representatives present were City Manager Matt McMahan, Police Chief Kimbre Collier, Finance Manager Stacy Smith, Building official Josh Kinnick and EDC director Joel Richardson. Cris Philyaw, assistant Fire Chief was present for the fire department. City Secretary was not present.

3. APPROVE MINUTES OF PREVIOUS MEETING: (November 2021)

Mayor Pro Tem Mosher made the motion to approve the previous minutes. Councilman Davies seconded the motion. The motion passed 3-0.

4. City Manager McMahan, advised that they are amending the water sales agreement with gallon per minute from Greenville, from 350 to 600. McMahan stated that with all the growth, this is crucial to modify. Mayor Pro Tem Mosher made the motion on amending the water sales agreement with the City of Greenville per attachment. Councilman Verity seconded the motion. The motion passed 3-0.

7. ACTION/DISCUSSION: Consider and Act on purchasing a Fire Truck for the CMFD.

Cris Philyaw, assistant fire chief, advised that he just pulled Engine 1 out of the shop. Also that the generator on Rescue 1 is out and will need to get that repaired. Philyaw stated that the new Rescue pumper comes with 750 gallons of water and it would be FD primary Fire Truck. Philyaw stated they have a trade in that would be at least 60k. Philyaw stated they would keep Engine 2 for a backup truck. The FD will pay the city quarterly payments. Councilman Davies made the motion on approving the Resolution 121421 for purchasing a Fire Truck for the CMFD. Councilman Verity seconded the motion. The motion passed 3-0.
